#### HCC Answer:

The current EAP provider for HCC is The University of Texas Health Science Center at Houston. EAP services have been provided to Houston Community College by the University of Texas Health Science Center since approximately1997.

#### **Question #2:**

What is the current Per Employee, Per Month (PEPM) cost or annual contract dollar amount?

#### HCC Answer:

The monthly cost per employee & family is \$2.69. The estimated annual contract cost is \$60,848.00.

#### **Question #3:**

How many face-to-face counseling sessions and hours of training are currently included within the PEMP?

#### HCC Answer:

Assessment, referral sessions and short-term counseling (1-5 sessions per employee per problem). Training: 42 Seminar hours with hand-out material.
