Q1. After inspecting, the HCC facilities there are windows that have Hard Water

stain on the glass at the present time. Will the prices submitted in the HCC bid

exclude the removal of Hard Water Stain from the glass?

Response: No. The Proposer must provide equipment, labor, supervision, materials,

supplies, and tools to perform all Services required under this RFP.

Q2. Are the prices submitted to HCC for using a soap and water solution only to

remove topical dirt from the glass?

Response: No. The Proposer must provide equipment, labor, supervision, materials,

supplies, and tools to perform all Services required under this RFP.

Q3. Clarification on interior window cleaning. Will the interior window cleaning of

any facility with an atrium exclude cleaning the atrium windows on the commons

area side and the classroom side?

Response: The requirements under the RFP incudes the perimeter of the building only.

The Contractor may provide pricing for atriums as additional services as an

option. The college may request the additional services needed basis.

Q4. Can HCC provide exterior window anchor certification clarification for the

following properties:

1900 Pressler – Coleman Building

• 1919 Pressler – Coleman Tower

• 8001 Fulton – Northline Campus

• 3100 Main – System Admin Building

Response: OSHA Anchorage Requirement Certifications will be provided to the successful

contractor(s) prior to work starting and after contract award.

Q5. There is a page titled "Section 2 - Price Proposal" but the instructions on Page No. 1 do not list this as part of what needs to be submitted, is it part of Attachment No. 1?

Response:

The Contractor is required to complete the Exhibit No. 2, Schedule of Items and Pricing Spreadsheet. The information from Exhibit 2 must be transferred to the group totals and annual total on the "Price Proposal" price summary. The Price Proposal must also be signed and returned with the spreadsheet as a final annual bid.

Q6. On Attachment No. 2, there is a blank to fill in a number for Small Business Participation Goal. Is there a required minimum for this number?

Response:

HCC encourages the use of small-certified business and when no specific goal is requested, respondents should make a "Best Effort" to include small business enterprises.

Q7. The instructions say to submit Exhibits No. 1 – No. 4. They are blank and openended and unclear to me what is needed on these, please advise? They include Campus Mapping, Schedule of Items and Prices Worksheet, Window Cleaning Plan of Service, and HCC Sample Form Services Agreement. Given there are over 50 buildings I am not sure what these are looking for.

Response:

The exhibits provided are as follows;

- 1. Exhibit No. 1 Campus Mapping is may be used as a tool to assist the respondent with finding the various HCC campuses and locations that requires windows and glass cleaning services.
- Exhibit No. 2 Schedule of Items & Pricing Spreadsheet is an itemized spreadsheet to be completed by the respondent and returned as your annual total bid.
- 3. Exhibit No. 3 HCC Window Cleaning Plan of Service is to be completed and provided by the selected fir(s) if awarded a contract.
- 4. Exhibit No. 4 Form Services Agreement for Business. This is HCC's sample contract service contract agreement provided to all contractors to review. If awarded the service agreement will be signed by all parties.
- Q8. What is the square footage of the windows interior or exterior for each location that needs to be cleaned?

Response: HCC will provide no estimated quantities or square footage information. Each proposer has the opportunity for site visits.

Q9. Some locations have cleaning specifications, which does not clean with regular cleaning; is this considered an additional cost?

Response: No. The Proposer must provide equipment, labor, supervision, materials, supplies, and tools to perform all Services required under this RFP,
