- 1.6 Specifications

#### 2. Vendor Selection

Except as provided by the Texas Education Code, Subchapter B, in determining to whom to award a contract, the District shall consider:

- 2. The reputation of the vendor and of the vendor's good or services;
- 3. The quality of the vendor's goods or services;
- 4. The extent to which the goods or services meet with the College's needs;
- 5. The vendor's past relationship with the College;
- 6. The impact on the ability of the College to comply with laws and rules relating to historically underutilized businesses;
- 7. The total long-term cost to the College to acquire the vendor's goods or services;
- 8. For a contract for goods and services, other than goods and services related to telecommunications and information services, building construction and maintenance, or instructional materials, whether the vendor or the vendor's ultimate parent company or majority owner:
  - a. Has its principal place of business in this state; or
  - b. Employs at least 500 persons in this state; and
- 9. Any other relevant factor specifically listed in the request for bids or proposals.

This section does not apply to a contract for professional services rendered, including services of an architect, attorney, certified public accountant, engineer, or fiscal agent. The District may, at its option, contract for professional services rendered by a financial consultant or a technology consultant in the manner provided by Section 2254.003, *Government Code*, in lieu of the methods.

#### 3. General Information

- 3.1 A person is not eligible to be considered for award of this solicitation or any resulting contract or to be a subcontractor of the proposer or prime contractor if the person assisted in the development of this solicitation or any part of this solicitation or if the person participated in a project related to this solicitation when such participation would give the person special knowledge that would give that person or a prime contractor an unfair advantage over other proposers.
- 3.2 A person or proposer shall not be eligible to be considered for this solicitation if the person or proposer engaged in or attempted to engage in prohibited communications as described in Section 3.9 Prohibited Communications and Political Contributions.
- 3.3 Award Approval this Procurement, any award under this procurement, and the resulting purchase order/contract, if any, is subject to approval by HCC Board of Trustees. Subsequent to Board approval, the only person authorized to commit HCC contractually is the Chancellor or designee. This solicitation is a formal Request for Proposal and neither this solicitation nor the response or proposal from any prospective proposer shall create a contractual relationship that would bind HCC until such time as HCC has issued a legally binding purchase order/contract, which includes, without limitation, the terms required by HCC as set forth in this Request for Proposal.
- 3.4 HCC Contact any questions or concerns regarding this Request for Proposal shall be directed to the Procurement Officer listed on the cover page. HCC specifically requests that proposers restrict all

- contact and questions regarding this Request for Proposal to the Procurement Officer. The Procurement Officer must receive all questions or concerns no later than the date and time listed in the Solicitation Schedule.
- 3.5 Inquiries and Interpretations responses to inquiries, which directly affect an interpretation or change to this Request for Proposal, will be issued in writing by addendum (amendment) and all addenda will be posted on the HCC Procurement Website. All such addenda issued by HCC prior to the time that proposals are received shall be considered part of the Request for Proposal, and the proposer shall be required to consider and acknowledge receipt of such in their proposal.

Only those HCC replies to inquiries, which are made by formal written addenda, shall be binding. Oral and other interpretations or clarification will be without legal effect. Proposer must acknowledge receipt of all addenda in Attachment No. 1 Request for Proposal Form.

3.6 Contract Award – award of a contract, if awarded, will be made to the proposer who (a) submits a responsive proposal; (b) is a responsible proposer; and (c) offers the best value to HCC, price and other factors considered. A responsive proposal and a responsible proposer are those that meet the requirements of and are as described in this solicitation. HCC may award a contract, based on initial proposal received, without discussion of such proposers. Accordingly, each initial proposal should be submitted on the most favorable terms from a price and technical standpoint, which the proposer can

submit to HCC. Except as otherwise may be set forth in this solicitation, HCC reserves the right to waive any informalities, non-material errors, technicalities, or irregularities in the proposal documents submitted and consider for award.

- 3.7 Postponement of Proposals Due Date/Time notwithstanding the date/time for receipt of proposal established in this solicitation, the date and time established herein for receiving proposals may be postponed solely at HCCs discretion.
- 3.8 Internship Program HCC is expanding its student internship program. All proposers are encouraged to make a commitment to utilize certain HCC student(s) in an internship capacity with the company under any resulting contract for the items required under this solicitation. At the sole discretion of the vendor, the internship opportunity may be paid or unpaid and shall be intended to serve as a relevant and meaningful educational enrichment opportunity for the HCC students involved. HCC will provide the selected proposer with the name of student(s) eligible to participate in the internship program.

- 3.9 Prohibited Communications and Political Contributions except as provided in exceptions below, political contributions and the following communications regarding this solicitation or any other invitation for bids, requests for proposal, requests for qualifications, or other solicitation are prohibited:
  - [1] Between a potential vendor, subcontractor to vendor, service provider, respondent, Offeror, lobbyist or consultant and any Trustee;
  - [2] Between any Trustee and any member of a selection or evaluation committee; and
  - [3] Between any Trustee and administrator or employee.

The communications prohibition shall be imposed from the day the solicitation is first advertised through thirty (30) days after the contract is executed by the Chancellor or his/her designee, or when a determination is made that the contract will not be awarded. During this period, no HCC Trustee and no vendor shall communicate in any way concerning any pending Solicitation involving the Vendor, subject to the penalties stated herein.

In the event the Board refers the recommendation back to the staff for reconsideration, the communication prohibition shall be re-imposed.

The communications prohibition shall not apply to the following:

- [1] Duly noted pre-bid or pre-proposal conferences.
- [2] Communications with the HCC General Counsel.
- [3] Emergency contracts.
- [4] Presentations made to the Board during any dulynoticed public meeting.
- [5] Unless otherwise prohibited in the solicitation documents, any written communications between any parties, provided that the originator shall immediately file a copy of any written communication with the Board Services Office. The Board Services Office shall make copies available to any person upon request.
- [6] Nothing contained herein shall prohibit any person or entity from publicly addressing the Board during any duly-noticed public meeting, in accordance with applicable Board policies, regarding action on the contract.

Any potential vendor, subcontractor vendor, service provider, proposer, offeror, lobbyist or consultant who engages or attempts to engage in prohibited communications shall not be eligible for the award of any resulting contract under this solicitation. Any other direct or indirect actions taken to unduly influence competitive purposes, to circumvent equal consideration for competitive proposers, or to disregard ethical and legal trade practices will disqualify proposers, vendors, service providers, lobbyist, consultants, and contractors from both this current and any future consideration for participation in HCC orders and contracts.

- 3.10 Drug Policy HCC is a drug-free workforce and workplace. The manufacture, sale, distribution, dispensation, possession or use of illegal drugs (except legally prescribed medications under physician's prescription and in the original container) or alcohol by proposers or contractors while on HCC's premises is strictly prohibited.
- 3.11 Taxes HCC is tax exempt as a governmental subdivision of the State of Texas under Section 501C (3) of the Internal Revenue Code. Limited Sales Tax Number: 1-74-1709152-1. No proposal shall include any costs for taxes to be assessed against HCC. The proposer shall be responsible for paying all applicable taxes and fees, including but not limited to, excise tax, state and local income tax, payroll and withholding taxes for proposer employees. The

purchase order/contract shall hold HCC harmless for all claims arising from payment of such taxes and fees.

- 3.12 Texas Public Information Act HCC considers all information, documentation and other materials requested to be submitted in response to this solicitation to be of a non-confidential and/or nonproprietary nature, and therefore, shall be subject to public disclosure under the Texas Public Information Act (Texas Government Code, Chapter 552.001, et seq.) ("The Act") after a contract if any, is awarded. If the proposer considers any information submitted in response to this Request for Proposal to be confidential under law or constitute trade secrets or other protected information, the proposer must identify such materials in the proposal response. Notwithstanding the foregoing, the identification of such materials would not be construed or require HCC to act in contravention of its obligation to comply with the Act and the proposer releases HCC from any liability or responsibility for maintaining the confidentiality of such documents.
- 3.13 Appropriated Funds the purchase of service or product, which arises from this solicitation, is contingent upon the availability of appropriated funds. HCC shall have the right to terminate the resulting contract at the end of the current or each succeeding fiscal year if funds are not appropriated by the HCC Board of Trustees for the next fiscal year that would permit continuation of the resulting purchase order/contract. If funds are withdrawn or do not become available, HCC reserves the right to terminate the resulting purchase order/contract by giving the selected contractor a thirty (30) day written notice of its intention terminate without penalty or any further obligations on the part of HCC or the contractor. Upon termination of the purchase order/contract HCC shall not be responsible for any payment of any service or product received that occurs after the end of the current contract period or the effective date of termination, whichever is the earlier to occur. HCCs fiscal year begins on September 1 and ends on August 31.
- 3.14 Conflict of Interest if a firm, bidder, proposer, contractor, or other person responding to this solicitation knows of any material personal interest, direct or indirect, that any member, official, or employee of HCC would have in any contract resulting from this solicitation, the firm must disclose this information to HCC. Persons submitting a proposal or response to this solicitation must comply with all applicable laws, ordinances, and regulations

of the State of Texas Government Code, including, without limitation, Chapter 171 and 176 of the Local Government Code. The person/proposer submitting a response to this solicitation must complete (as applicable), sign and submit Attachment No. 3, Conflict of Interest Questionnaire Form, and Attachment No. 4, Financial Interest and Potential Conflict of Interests with the proposal package. HCC expects the selected proposer to comply with Chapter 176 of the Local Government Code and that failure to comply will be grounds for termination of the contract.

Note: Attachment No. 3 and Attachment No. 4 shall be completed signed and returned to HCC. Enter N/A in those areas on the Attachments that are not applicable to your company. Failure to complete, sign and notarize (if applicable) these Attachments may render your proposal non-responsive.

- 3.15 Ethics Conduct any direct or indirect actions taken to unduly influence competitive purposes, to circumvent equal consideration for competitive proposers, or to disregard ethical and legal trade practices will disqualify vendors and contractors from current and future consideration for participation in HCC orders and contracts.
- 3.16 No Third Party Rights the resulting purchase order/contract is made for the sole benefit of HCC and the Contractor and their respective successors and permitted assigns. Nothing in this Purchase Order/Contract shall create or be deemed to create a relationship between the Parties to this Purchase Order/Contract and any third person, including a relationship in the nature of a third party beneficiary or fiduciary.
- 3.17 Withdrawal or Modification no proposal may be changed, amended, modified by telegram or otherwise, after the same has been submitted or filed in response to this solicitation, except for obvious errors in extension. However, a proposal may be withdrawn and resubmitted any time prior to the time set for receipt of proposals. No proposal may be withdrawn after the submittal deadline without approval by HCC, which shall be based on proposer's submittal, in writing, of a reason acceptable to HCC.
- 3.18 Submission Waiver by submitting a response to this Solicitation, the Offeror or respondent agrees to waive any claim it has or may have against Houston Community College System and its trustees, employees or agents arising out of or in connection with (1) the Administration, evaluation or

recommendation of any offer or response; (2) any requirements under the solicitation, the solicitation or response package or related documents; (3) the rejection of any offer or any response or any part of any offer or response; and/or (4) the award of a contract, if any.

- 3.19 Indemnification proposer shall indemnify, pay for the defense of, and hold harmless the College and its officers, agents and employees of and from any and all liabilities, claims, debts, damages, demands, suits, actions and causes of actions of whatsoever kind, nature or sort which may be incurred by reason of proposer's negligence, recklessness, or willful acts and/or omission in rendering any services hereunder. Proposer shall assume full responsibility for payments of federal, state and local taxes or contributions imposed or required under the social security, Workers' Compensation or income tax law, or any disability or unemployment law, or retirement contribution of any sort whatever, concerning Contractor or any employee and shall further indemnify, pay for the defense of, and hold harmless the College of and from any such payment or liability arising out of or in any manner connected with Contractor's performance under this Agreement.
- 3.20 Delegation unless delegated, HCC Board of Trustees must approve all contracts valued at over \$100,000. The Board has granted the Chancellor authority to initiate and execute contracts valued up to \$100,000. The procurement of goods and services, including professional services and construction services shall be completed as per any applicable HCC policy and procedure and shall be in accordance with Section 44.031 of the Texas Education Code for the purchase of goods and services, Section 2254 of the Texas Government Code for the purchase of Professional and Consulting Services, and Section 2269 of the Texas Government Code for the purchase of construction services. The Board delegates its authority to the administration and the designated evaluation committee to evaluate score and rank the This includes the evaluation of all proposals. propoals, proposals, or statements of qualification under procurement, regardless of contract amount, including the final ranking and selection which shall be made on the evaluation and scoring as per the published selection criteria and the final evaluation ranking. The Board of Trustees shall approve the final award of contracts to the firm based on the published selection criteria and as evidenced in the final evaluation, scoring and ranking.

- 3.21 Invoice to facilitate payment, invoices for goods or services delivered in accordance with the resulting purchase order/contract shall be emailed to the Accounts Payable Department with copy to the Small Business Development Program. Pursuant to Texas Law, payment terms shall be net thirty (30) days.
  - All invoices shall include certified documentation noting any small business participation activity including but not limited to: small business firm's name, certification number, certification expiration date, description of work performed for the corresponding period noted on the invoice and amount being paid to the certified small business. Such documentation shall be certified by the small business and be used to monitor the ongoing small business commitment in accordance with the original proposed commitment and governing contract.
- 3.22 Cooperative Purchasing Agreement as permitted under Interlocal Cooperation Act C Government Code, Chapter 791, other governmental entities may wish to also participate under the same terms and conditions contained in this contract. If this solicitation does not specifically list additional entities, each entity wishing to participate must have prior authorization from Houston Community College and the vendor. If such participation is authorized, all purchase orders will be issued directly from and shipped directly to the entity requiring the goods or services. Houston Community College shall not be held responsible for any orders placed, deliveries made or payment for goods or services ordered by the entities. Proposer is to state their willingness to allow other governmental entities to participate in this contract, if awarded.
- 3.23 W9 Form Proposer shall include a W9 Form with their proposal submission.

#### 3. Scope of Services

The proposer will provide all materials, equipment labor, insurance, supervision, tools, supplies, and other expenses necessary to provide and deliver Window and Glass Cleaning Services.

#### 1. Project Details

- a) Proposer(s) shall provide Services for all HCC locations including those listed on HCC's College Campuses Map. (Refer to Exhibit No. 1 titled, "Campus Mapping")
- b) This solicitation is to provide interior and exterior window and glass door cleaning services once per year and as scheduled on an "as-needed" basis at various location(s) as designated in the solicitation. The scope of service covers the requirements for the Contractor to furnish all labor and material and any other resources required to provide Window and Glass Cleaning Services which includes exterior (outside) and interior (inside) of windows for the Houston Community College System. All services required herein shall be performed in a workman like manner.

Window washing services shall be defined as:

- Washing perimeter windows (exterior & interior) and some select indoor windows/glass
- Removal of hard water spots
- Wiping window sills clean and dry
- c) Window washing will be scheduled as needed with the Facilities Department or Designee. All necessary equipment, tools, supplies, personnel and transportation shall be included in the cost of window washing.
- d) Houston Community College expects all glass to be cleaned as part of this contract. It is the bidder's responsibility to account for all of the glass surfaces by a review of the campuses prior to submitting their bid and also at the time of service(s). Facilities operations personnel may be contacted and available to answer any questions.

- e) Cleaning of all glass shall be done to the satisfaction of the Director of Facilities Maintenance or designee and any glass found to be unacceptable shall be re-cleaned at no additional charge to the college, and until approved by the campus manager.
- f) The Contractor is responsible for accessing all glass to be cleaned. The Contractor is also required to provide all equipment and supplies necessary to complete tasks. The Contractor is responsible for the safety inspection and safe use or any/all Davit, Docking, Lifting or any other systems/equipment that may be used by the contractor to access glass for the purpose of cleaning.
- g) The Contractor shall be responsible for the repairs to any property, equipment or landscape that may be damaged as a result of contractor's negligence.

#### 2. Mandatory Requirements/Conditions

- a) Proposer(s) shall provide at their own expense all equipment, labor, supervision, materials, supplies, and tools to perform all Services required under this RFP, including equipment to facilitate Services for windows of all heights (e.g. lifts). Proposer(s) shall provide documentation to HCC that lift operators are properly trained and/or certified to operate the equipment should any lift equipment be utilized.
- b) Proposer(s) shall ensure that all of its employees comply with all Occupational Safety and Health Administration (OSHA), state and city safety and occupational health standards and other applicable federal, state, and local health, safety, and environmental laws, ordinances, rules, and regulations in the performance of the Services (Reference OSHA.gov and EPA.gov).
- c) Proposer(s) shall utilize equipment and cleaning chemicals that will not cause damage to window frames, building exterior, or any surrounding materials including plants ("Appropriate Products"). Any pre-existing damage shall be reported to HCC prior to services taking place.
- d) A Material Safety Data Sheet (MSDS) must be provided to the Safety Department of HCC for any chemical used. HCC reserves the right to reject the use of any given product.
- e) Proposer(s) must be able to respond to requests for Services from HCC within 72 hours.
  - HCC will arrange the exact date and times for Services.
  - Services must be available on schedules such as annually, semiannually, quarterly, monthly, or as needed, as applicable.
- f) Proposer(s) shall clean all surfaces using the Appropriate Products to obtain a uniformly bright surface that is free of drips, streaks, residue, smudges, smears and foreign material, including hard water spots and bird droppings. HCC shall be allowed to perform inspections upon completion of Services. Payment will not be made until Services are completed to the satisfaction of HCC.
- g) Proposer(s) shall remove all moisture on the window sills and frames with a clean cloth.
- h) Proposer(s) shall remove any adhered hydrophobic solid with the use of an appropriate cleaning agent.
- i) Proposer(s) shall remove all equipment, materials, and supplies from the work areas at the end of the workday.
- j) Proposer shall provide uniforms and ID badges for all employees working on HCC property.

No employee of the Proposer will be allowed on HCC properties out of uniform or without an ID badge.

k) Proposer(s) shall coordinate the location of services and any key issuance needed with HCC Facilities Operations Department if working within or on any educational or general buildings.

#### 3. Preferred Requirements/Conditions

- a) HCC would prefer that Proposer(s) have at least five (5) years of experience in providing services for similar buildings and facilities.
- b) Proposer(s) should document in their proposal whether they provide environmentally friendly or "green" alternatives to the use of harsh chemicals.

#### 4. Contractor's Lead Personnel

- a) The identity and contact information of the lead worker must be provided to the Director of Maintenance upon award of contract. The lead worker must be available for contact by the Facilities Department at all times while on campus.
- b) The Contractor's designated lead worker must not be changed for the duration of the contract unless agreed upon in writing by the contractor and Houston Community College Facilities Department and Procurement Operations Contract Administration.

#### 5. Contractor's Employees

- a) Contractor's employees must maintain a courteous and respectful attitude toward the public, their fellow workers and supervisors at all times. At no time shall there be any soliciting or requesting of gratuities of any type. Workers must act appropriately and professionally at all times. Offensive language, gestures or actions while on campus are not acceptable. The Facilities Department may require the contractor to reassign any employee the Facilities Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on campus.
- b) No employee convicted of theft, assault, sex offense or drug use/possession/sale shall be allowed to work on the campus. The Contractor is strictly prohibited from allowing a person with these types of convictions to perform work under this contract. After award and immediately upon receipt of such conviction information, the Contractor shall not allow that employee to provide service under this contract and will notify the College of that employee's change of status in writing. Verification of criminal background checks shall be made available to the College upon request.
- c) When performing service under this contract, Contractor employees will wear official companylogo uniforms and wear official company logo ID photo-badges displaying the employee's full name that is visible to someone standing in front of the employee. Employees should drive official company vehicles with company logo.

#### 6. Unauthorized Personnel/Animals

- a) The Contractor will provide to the College a list of authorized employees who will perform services under this contract who have been properly trained, who have not been convicted of a theft, assault, sex offense or drug use/possession/sale, and who are over eighteen (18) years of age. The list will be kept current at all times.
- b) At no time during the performance of this contract will unauthorized personnel accompany

Contractor employees on the job. Unauthorized personnel describes any persons not on the above described list including children, relatives, and friends. Contractor employees will not bring animals onto College property or into College buildings and will not leave their animals in their vehicles while working at the College.

#### 7. Supervision and Inspections

- a) The Contractor or appointed lead worker will provide adequate supervision at all times while any Contractor employees are on the College's property in the performance of this contract. The Contractor/lead worker will provide this on-site supervision for security purposes and to assure that all services are performed appropriately.
- b) The Contractor/lead worker will inspect all work done to verify that the window cleaning performed complies with requirements.
- c) A checklist will be provided by the Contractor containing all windows that have been cleaned and inspected. Each building on the checklist is to be initialed by the cleaner when the cleaning is complete.
- d) The Contractor/lead worker will sign the checklist and submit via email to the College's Facilities Department for work verification. This shall be done within two (2) hours of cleaning completion.
- e) The Contractor/lead workers will note on the checklist any maintenance or safety problems regarding windows such as broken glass or locks which are identified while cleaning or performing the checklist inspection. Using the checklist submitted by the Contractor, an inspection will be made by the Facilities Department. The Contractor will be called back at no cost to the College to remedy any deficiencies noted.
- f) Payment will be withheld until cleaning is satisfactorily completed and the Facilities Department signs off on the satisfactorily completed work.

#### 8. Equipment

- a) The Contractor will furnish all cleaning equipment and supplies as needed, as well as, any equipment required to carry out the scope of work. The Contractor must have the ability to provide boom truck for certain facilities as needed. The Contractor must have extension ladders and extension poles for high work.
- b) A list of chemicals to be used in the performance of these services shall be submitted to the HCC Safety Department of Facilities Department for written approval prior to any cleaning taking place. Safety Data Sheets (SDS) shall be provided for each and every chemical approved for use by the College in the course of this service.
- c) The Contractor must get approval from the Facilities Department to place any equipment on sidewalks. If equipment is used and positioned off of sidewalks, Contractor must supply and strategically place construction decking of sufficient strength to protect all areas where equipment will be driven/placed. Plywood, if used, shall be at least <sup>3</sup>/<sub>4</sub>" thick.
- d) The Contractor will leave the premises in the same condition as found. Trash or debris generated by the Contractor will be completely removed from the College campus before completion of the job.
- e) The College will not be responsible for materials, equipment, or supplies that are left on any Houston Community College campus.

#### 9. Building Access and Security

- a) No work is to be done without prior scheduling. The contractor shall work standard business hours (Monday through Friday, 7:00 AM to 5:00 PM) unless otherwise requested and approved.
- b) Any work that could possibly disrupt the flow of foot traffic on campus may be scheduled during off-hours. The Contractor is responsible for identifying off-hour work requirements prior to beginning the work. Off-hours are all hours including holidays that are not standard business hours.
- c) The Contractor must immediately notify the Facilities Department of any situations that present a safety issue. The Contractors will be provided the office and cell phone numbers of required Facilities Department personnel.

#### 10. Storage

Houston Community College will not provide storage of any of the Contractor's materials, equipment and supplies.

#### 11. Damage

- a) The College shall not be responsible for damage or loss to Contractor's equipment and materials on College property.
- b) The Contractor shall be responsible for the repair of any property damage caused by the Contractor's equipment or personnel. Wherever any existing material, equipment or appurtenances are damaged by the Contractor or by the Contractor's failure to provide proper and adequate protection, the cost of repair or replacement shall be charged to the Contractor. Items covered by this provision include but are not limited to, buildings, vehicles, roads, parking lots, street lights, curbs, sidewalks, fences, lawns, irrigation or plumbing equipment, plantings, trees, signs, and refuse containers. The decision to repair or replace shall be at the sole discretion of the College's Facilities Department.
- c) Items that are damaged by the Contractor that the College's Facilities Department deems replaceable shall be paid for by the Contractor at replacement cost for the item. In order to minimize damage, the Contractor is expected to drive and park only where vehicles are normally allowed.
- d) Injuries to any person, prior damage not caused by the Contractor, and damage caused by the Contractor to College property, the property of College residents, College staff, or any property not belonging to the Contractor must be reported immediately to the College's Facilities Department.
- e) Payment for window cleaning services will be withheld until all repairs are completed.

#### 12. Lost and Found and Safety

- a) Anything of value found by the Contractor while performing services under this contract must be returned to the Facilities Department.
- b) The Contractor must immediately notify the Facilities Department of any situations that present a safety issue.

#### 13. Parking

The successful Contractor is required to park in designated parking spaces while on the College campus, and adhere to HCC's parking policies. Any citations received by the Contractor for failing to abide by the parking regulations shall be the Contractor's responsibility to pay.

#### a) Contractor to Comply with Laws

In the performance of this contract, the Contractor agrees that all service must be performed in accordance with all government regulations and agrees to abide by all OSHA rules and regulations and all other existing laws, codes, rules and regulations set forth by all appropriate authorities having jurisdiction in the location where the work is to be performed. The Contractor also agrees to handle the disposal of toxic and hazardous materials and waste according to federal, state and local regulations.

b) The Contractor must ascertain, observe and comply with all rules and regulations in effect on the work site including but not limited to parking, traffic laws, use of walks, security restrictions, hours of allowable ingress and egress.

#### 14. Inclement Weather

- a) In the event of inclement weather conditions effects the likelihood of providing glass and window cleaning services during the performance of the Scope of Work, work schedule must be continued later the same day, or as soon as conditions permit.
- b) The Contractor shall not perform window/glass cleaning services during inclement weather conditions and must work with the individual campus manager to reschedule the work.

### 15. Specification

Quality of Work:

- a) Windows shall be washed clean and free of steaks, smears, and visible soap residue. Accumulated dirt, paint specs, or other foreign debris must be scraped from windows.
- b) Frames shall be scrubbed to remove all dried dirt, insects, debris and other materials so as to be considered clean by the building representative.
- c) Windowsills shall be washed clean and all drippings wiped dry.

Note: The Contractor will not be responsible for any stain or scratches etched or embedded in the glass, unless such is caused by the Contractor's employees.

#### 16. Quality Measures

- a) All workmanship and materials delivered by Proposer(s) to HCC are subject to inspection and approval by HCC.
- b) If for any reason HCC is not satisfied with the Services, Proposer(s) shall resolve the problem with no additional charge.

#### 16.1 Warranty of Services

a) *Definitions*: "Acceptance" as used in this clause, means the act of an authorized representative of HCC's Facilities Maintenance Director and/or designee by which HCC

assumes for itself, approval of specific services, as partial or complete performance of the Contract must be in writing.

- b) "Correction" as used in this clause, means the elimination of a defect.
- c) Notwithstanding inspection and acceptance by HCC or any provision concerning the conclusiveness thereof, the Contractor warrants that all services performed under this Contract will, at the time of acceptance, be free from defects in workmanship and conform to the requirements of this Contract. HCC shall give written notice of any defect or nonconformance to the Contractor within a one-year period from the date of acceptance by HCC. This notice shall state either (1) that the Contractor shall correct or re-perform any defective or nonconforming services at no additional cost to HCC, or (2) that HCC does not require correction or re-performance.
- d) If the Contractor is required to correct or re-perform, it shall be at no cost to HCC and any services corrected or re-performed by the Contractor shall be subject to this clause to the same extent as work initially performed. If the Contractor fails or refuses to correct or re-perform, HCC may, by contract or otherwise correct or replace with similar services and charge to the Contractor the cost occasioned to HCC thereby, or make an equitable adjustment in the Contract price.
- e) If HCC does not require correction or re-performance, HCC shall make an equitable adjustment in the contract price.

#### 17. Additions and Deletions

HCC, by written notice to the Contractor, at any time during the term of this contract, may add or delete like or similar locations and/or services to the list of locations and/or services to be performed. Any such written notice shall take effect on the date stated in the notice from the College. The Contractor will be requested to provide a fee equal to their normal and customary charges or rates for the locations and/or services requested.

#### 18. Estimated Quantities Not Guaranteed

The estimated quantities specified herein are not a guarantee of actual quantities, as HCC does not guarantee any particular quantity of glass windows and entrance doors cleaning services during the term of this contract. The quantities may vary depending upon the actual needs of the College. The quantities specified herein are good faith estimates of usage during the term of this contract. Therefore, HCC shall not be liable for any contractual agreements/obligations the Contractor enters into based on all the quantities specified herein.

#### 19. Window Cleaning Plan of Service (Refer to Exhibit No. 3)

- a) The Contractor shall be required to develop a site-specific service and emergency recovery plan for each location to be cleaned. Location refers to a specific area, such as a building where the Contractor will clean windows. The Contractor does not have to develop a separate plan for each side or face of a building unless conditions vary greatly from one side or area to another.
- b) A copy of this plan must be submitted to the Project Manager prior to services being provided and must be kept at the worksite during the entire cleaning operation.

### 20. Compliance with Applicable Laws and Regulations:

Service provider shall perform all requirements under this contract in strict observance of and in compliance with all applicable laws, regulations, ordinances, codes and any other legislative or statutory requirements. Service provider warrants the performance of services under this contract shall be fully compliant with the current requirements of the Occupational Safety and Health Act (OSHA) to include as it may be amended throughout the term of this contract. Service provider shall take precautions to insure work is performed in compliance with occupational safety standards. Service provider shall obtain all permits and licenses and pay all taxes, charges and fees necessary to perform the services under this contract.

Schedule: First week of each month for First and Second floors

#### 1. System Administration Building – 3100 Main:

Clean the perimeter windows and glass doors (interior and exterior) on the entire first and second floors, work should include detail cleaning of all window and door frames and windowsills.

#### a) First Floor Service to Include:

All glass located at the entrance doors facing Elgin Street, Main Street and Travis Street. All brown colored glass panels between the first and second floors cleaning/washing of the "Brown Wrapped Columns" and exterior Vents throughout the perimeter of the building.

#### 2. Sky Bridge:
