- Subject: Questions and Answers Responses

Q1.	Will the contractor have access to water at the locations? If so, is it metered?
Response:	Yes and water use is metered
Q2.	Do we need to provide a water meter reader?
Response:	Yes, the awarded contractor(s) shall report on the amount of water utilized for each Task/Work order.
Q3.	Can you clarify the Vertical height and Sqft relationship? There is $>10' - 20'$ Vertical with Up to 5,000 sqft. I visited the Spring Branch location which is about 20' but the building is 133,192 sqft. What happens when the build vertical is in a range but the sqft. is far greater than the sqft range?
Response:	The College may Bid larger individual projects where an entire structure or building with a specific scope requires pressure washing. For projects where the building or structure are in a vertical range, HCC may also elect to have contractors that are part of the pool provide pricing based on the specific square footage.
Q4.	Is Linear the same as horizontal surfaces like parking lots, garage ramps, sidewalks, etc? If not, what does Linear mean with examples?
Response:	Linear / Horizontal is referring to flatwork surfaces.
Q5.	Are Rows 29 and 32 duplicates of >25,000sqft?
Response:	Please refer to solicitation amendment No.001 for Exhibit No. 2 PRICING WORKSHEET (Amended).
Q6.	On page 6 - I would like to clarify the 3,200 psi at 8 gpm. Can we reduce the pressure to 2,500psi and use 10 gallons per minute? This has the same "cleaning factor".
Response:	Vendors should bid what is in the Scope of Work
Q7.	On page 7h - The Pricing Worksheet has Vertical and Linear categories with different pricing. When we do a building with sidewalks, do you use the Vertical pricing for the building walls and the Linear (assume flat surfaces) pricing for the sidewalks?

- **Response:** Vertical pricing shall be used for walls and Horizontal pricing shall be used for flatwork.
- Q8. Concrete and other surfaces are porous so some pollutants such as oil, grease, mold, and others cannot be completely removed leaving some degree of staining. What happens if the HCC rep does not realize there is a limit to what cleaning solutions and washing can do leaving a slight stain?
- **Response:** If a dispute cannot be resolved by the onsite college representative and awarded contractor, the awarded contractor shall have the opportunity to escalate the issue to supervisory staff.
- Q9. We are fairly new to pressure washing and understand there could be a pool of prime contractors. We are going to submit as Prime knowing we cannot do all the jobs and do not have Subs to do what we cannot. In the bid can we select specific jobs to create our Total? If we are included, could other jobs be assigned at our rate?
- **Response:** This is an Indefinite Quantity, Indefinite Delivery Contract on an as needed basis, therefore there are no specific Jobs identified.
